- Failure to pay when due the balance of the agreed to pricing;
- The business failure, or the failure or inability to pay debts in the ordinary course or as they become due or insolvency with federal bankruptcy laws or state/province insolvency laws or otherwise;
- The commission of any act of bankruptcy, assigned for the benefit of creditors, composition of creditors or the commencement of any proceedings, whether voluntary or involuntary, under any federal or state/provincial bankruptcy, reorganization, or insolvency laws.

Casella reserves the right to cancel the credit offered herein for late payment, non-payment or other justified cause judged solely by Casella.
